MRI OF THE LUMBAR SPINE:

HISTORY: 25-year-old gentleman referred for screening MRI examination of the lumbar spine.

TECHNIQUE: Standard MRI pulse sequences of the lumbar spine without contrast were performed on a high-field 3.0 Tesla MRI.

FINDINGS: The sagittal images show very slight posterior slippage of L5 on S1. No lumbar fracture. No focal aggressive lumbar mass marrow lesion.

L5-S1: Very slight posterior slippage. No disc herniation, nerve root impingement or central lumbar spinal canal stenosis. No significant lumbar facet arthrosis.

L4-5: Slight lumbar degenerative facet arthrosis. No disc herniation, nerve root impingement or central lumbar spinal canal stenosis.

L3-4: No disc herniation, nerve root impingement or central spinal canal stenosis. No significant facet arthropathy.

L2-3: No disc herniation, nerve root impingement or central spinal canal stenosis. No significant facet arthropathy.

L1-2: No disc herniation, nerve root impingement or central spinal canal stenosis. No significant facet arthropathy.

T12-L1: No disc herniation, nerve root impingement or central spinal canal stenosis. No significant facet arthropathy.

To view reports from the FINAL RESULTS workflow, select the patient by clicking anywhere except for their name in blue and their report will show on the right side. A patient is selected when their line is highlighted in blue. If the name in blue is selected it will bring up the patient's chart. To view the images click on DICOM
